<b>Notes</b>	<p><i>Dr. Hobson expressed the view that General Practitioners and pharmacists could strengthen primary care by establishing a newly formed collaborative. This organisation would be positioned to bid for tenders issued by the Integrated Care Board (ICB).</i></p> <p><i>However, such a development would require initial investment.</i></p> <p><i>Dr. Hobson proposed that an investment of approximately 5–10 pence per patient would be required from General Practitioners. He noted that the level of investment expected from pharmacies had not yet been determined, but this would be discussed in due course.</i></p> <p><i>He plans to present the proposal formally to General Practitioners over the coming weeks.</i></p> <p><i>He also emphasised his intention to involve pharmacies in the collaborative and indicated that similar proposals would be extended to dentists and optometrists.</i></p> <p><i>The organisation would be established as a Community Interest Company (CIC), ensuring that any profits generated would be reinvested into primary care.</i></p>
